II. Privacy Policy

This page explains how and when your personal data is collected, processed and used when accessing hardmood.info or any of its subdomains. Basis of all processing are the terms of the [General Data Protection Regulation](#) (GDPR).

A. Scope and purpose of the collection, processing and use of personal data when visiting this website

This data is collected and processed for the purposes of facilitating use of this website (creating the connection), guaranteeing long-term system security and stability, for technical administration and optimising this web service, and for internal statistical purposes. The data will be deleted automatically after a period of six months.

B. Transfer of Data to Third Parties

There will be no transfer of personal data to third parties until the user has expressly agreed to this or if the operator will be under a legal obligation to do so. Transfer to third parties for other purposes will not take place.

C. Right to Information, Correction, Blocking and Deletion
