## II. Privacy Policy

This page explains how and when your personal data is collected, processed and used when accessing [hardmood.info](http://hardmood.info) or any of its subdomains. Basis of all processing are the terms of the [General Data Protection Regulation](#) (GDPR).

## **B. Transfer of Data to Third Parties**

## **C. Right to Information, Correction, Blocking and Deletion**
